**Installation:** Mount the tubular daylight device (TDD) to a wood curb. Use a minimum 2x8 Douglas Fir-Larch dimension lumber wood curb. Design the wood curb and the attachment of the wood curb to the roof framing to resist the design pressures of the TDD assembly as specified in this evaluation report. Design of the wood curb and the attachment of the wood curb to the roof framing must be done by a Texas licensed engineer.

Secure the TDD to the wood curb using the vertical apron of the curb cap assembly with minimum No.  $10 \times 2$ " Phillips truss head screws. Locate four fasteners along each side of the assembly. Place the fasteners through the pre-cut holes in the vertical apron of the curb cap assembly approximately 2-1/2" and 10" from each corner. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wood framing.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC, the IBC, and the Texas Revisions.
